PLEASE READ THIS ENTIRE LIMITED WARRANTY, AS EXCLUSIONS AND CONDITIONS APPLY.

#### 10 YEARS SPA SHELL STRUCTURE

Sundance® Spas, Inc. warrants against water loss due to defects in the spa shell for ten years from the original date of purchase.

#### 7 YEARS SHELL SURFACE

Sundance® Spas, Inc. warrants the interior surface of the spa shell against blistering, cracking, or delaminating due to defects in workmanship or materials for seven years from the original date of purchase.

#### 5 YEARS CABINET

Sundance® Spas, Inc. warrants the SunSide™ synthetic cabinets against defects in workmanship or materials for five years from the original date of purchase. Normal wear and weathering of the finish will occur naturally over time, and are not defects.

#### 5 YEAR JETS

Sundance® Spas, Inc. warrants the jets and jet fittings against defects in workmanship or materials for five years from the original date of purchase.

#### 5 YEARS PLUMBING

Sundance® Spas, Inc. warrants factory installed plumbing against water loss due to defects in workmanship or materials for a period of five years from the original date of purchase.

#### 5 YEARS EQUIPMENT & CONTROLS

Sundance® Spas, Inc. warrants the spa's electrical equipment components, specifically the pumps, heater, air blower, and control system against malfunctions due to defects in workmanship or materials for five years from the original date of purchase.

#### WARRANTIES FOR OTHER COMPONENTS

The fuses, headrests, cabinet finish, quick release latch and filters are warranted to be free of defects in workmanship or materials at the time of delivery. The factory installed CLEARRAY® Water Purification system and CLEARRAY® PROTECT™ ozone system are warranted against malfunctions due to defects in workmanship, materials, and leaks for one year from the original date of purchase except the UV-C bulb and quartz tube. The UV-C bulb and quartz tube is warranted for ninety (90) days from the original date of the spa purchase. Factory installed ozone is warranted against malfunction due to defects in workmanship or materials for one year from the original date of spa purchase. All stereo related components are warranted against malfunction due to defects in workmanship or materials for two years from the original date of purchase. The factory installed SmartTub™ system option is warranted against

malfunction due to defects in workmanship or materials for one year from the original date of spa purchase. All other factory installed components not mentioned specifically, including, but not limited to the wood frame, diverter valves, LED lighting systems, filter lids, and mechanical components are warranted against malfunction due to defects in workmanship or materials for two years from the original date of purchase.

#### PARTS & ACCESSORIES

Genuine Sundance® Spas Parts & Accessories - This Limited Warranty is void if Sundance® Spas, Inc. ("Manufacturer") or its designated representative determines that the spa has been subjected to damage or failure due to installation of aftermarket parts that are not Genuine Sundance® Spas branded Parts & Accessories. This disclaimer includes, but is not limited to filters, UV-C bulbs, ozone systems, repair parts and other accessories. Genuine Sundance® Spas brand Parts & Accessories are built to our highest standards of quality, durability and performance, and they are designed to work with your spa to ensure optimal performance and function.

#### PERFORMANCE

Please register your new spa within 7 days of delivery. You can register your new spa at <https://www.sundancespas.com/en-us/owners/register-your-product>. The spa must be registered before any authorized service work can be performed. To obtain service in the event of a defect covered by this Limited Warranty, contact your Sundance® Spas dealer or Sundance® Spas, Inc. (address below) as soon as possible and use all reasonable means to protect the spa from further damage. Upon proof of purchase, a designated service representative will correct the defect subject to the terms and conditions contained in this Limited Warranty. There will be no charge for parts or labor to repair the defect, although providing access to perform the repair is your responsibility as the spa owner. You may be assessed reasonable travel and mileage charges by the service representative. In the event that the spa is removed to a repair facility for repair and reinstalled, the cost of removal and reinstallation will be your responsibility as the spa owner. Sundance® Spas reserves the right, at its sole option, to either repair or replace any covered part or spa, and in the event it chooses to provide a replacement spa, it will be of equal value of the original spa. In such an event, reasonable costs for removal of the original spa, shipping costs from the factory for the replacement spa, and delivery and installation of the replacement will be your responsibility as the spa owner. The replacement spa will carry the balance of the original spa's warranty. Spa covers are not included.

This Limited Warranty is void if Sundance® Spas or its designated representative determines that the spa has been subjected to alteration, neglect, misuse, abuse, extraordinary wear, failure to follow directions, improper maintenance, or freight damage caused by a common carrier; any damage caused by repairs that have been attempted by anyone other than a designated representative; damage or

failure due to installation of aftermarket parts that are not Genuine Sundance® Spas branded parts & accessories; damage or failure due to service or repair by someone other than Sundance® Spas or its designated representative using authorized Sundance® Spas parts; or if the failure is caused by accident, acts of God or other causes beyond the control of Sundance® Spas. Neglect, misuse and abuse also include any installation, operation or maintenance of the spa other than in accordance with the instructions contained in the owner's manual provided with the spa, including but not limited to the failure to maintain proper water chemistry and chemical balance and the use of abrasive or improper cleaners. This Limited Warranty does not provide coverage for any item attached to or installed on the spa after the date of manufacture, or for gaining access to any component for repair or replacement. Spa units used in a commercial application are excluded from any coverage whatsoever. The spa owner accepts liability for repair work performed by anyone other than Sundance Spas or its designated service representative.
